## Fellow Lake of the Oaks Property Owners;

Please be aware that a huge hog confinement operation (8500 head of hogs) is currently seeking State approval to start up less than two miles southeast of our lake. Many people believe that this proposed operation poses a very serious potential problem for our Lake of the Oaks water quality.

Please read the material below and express your written opinions to the officials listed. A form letter is attached (feel free to make additional copies or use as your model for your letter) for your use in communicating your concerns.

It has come to light that Expedition Acres, LLC, located in Carthage Illinois is planning construction of a new CAFO (Concentratrated Animal Feeding Operation) approximately 5-7 miles northwest of Canton, Mo. and approximately 3 miles southeast of St. Patrick, Mo. Based on Expedition Acres' animal court information, this operation will house 8,500 swine. However because this proposed CAFO fits into a class 1B Category, the number of swine could soar to 17,000.

The location of this proposed CAFO is near Canton's water treatment plant and wells. The potential for water contamination of our water quality is possible due to waste runoff and drainage, excessive rainfall following manure applications, other natural disasters, accidental spills, broken pipes or faulty construction of the facility.

If you are concerned about this issue, it is imperative that you WRITE the Missouri Department of Natural Resources requesting a public hearing to address the safety of our water supply. The department reviews all comments, however, due to current legislation, it can only consider water quality issues within the jurisdiction of Clean Water Commission. Time is of the essence and letters or emails should be sent soon as possible.

Attached you will find a sample letter. You may fill in the blanks with the designated information and post it to the above mentioned address, copy and send it via e-mail or compose your own letter. It is important that when you write to the above mentioned people, that you include the following information:

- Identify yourself and include your address and/or email. It is very important that if you are a
  nearby land owner, you stress that point.
- State that Expedition Acres, LLC is planning construction of a CAFO northwest of Canton, MO.
- Express and emphasize your concerns about water quality.
- Request a public hearing.

Please note that concerns regarding air pollution, falling property values, health threats, deterioration of roads and other scourges are not addressed by the DNR when issuing a permit. By law, it will only consider water quality issues within the jurisdiction of the Clean Water Commission and when an operation meets all state requirements the department is required to issue a permit to such an operation.
